 FEDERALLY MANDATED COST ADJUSTMENT FACTOR

The Federally Mandated Cost Adjustment ("FMCA") Factor in Rates 711, 720, 721, 722, 723, 724, 725, 726, 732, 733, 734, 741, 742, 744, 750, 755 and 760 and Rider 776, shall be computed in accordance with Rider 787. The FMCA Factor for Rider 776 will be the FMCA Factor associated with the firm service Rate Schedule, either Rate 732 or 733, being used in conjunction with this Rider.
