

Price, Terms, and Conditions



The Green Path Rider is a voluntary, volumetric rider available to eligible residential and non-residential general sales service customers who are focused on their carbon footprint and would like the option to decarbonize an equivalent amount of some, or all the emissions related to their natural gas consumption. Collections from the Green Path Rider will be used to purchase Renewable Natural Gas (“RNG”) environmental attributes and Carbon Offsets. This program is governed by NIPSCO’s Gas Service Tariff, as well as Terms of Rider 291 – Green Path Rider.

Who is eligible to enroll?	<p>The Rider is available to:</p> <ul style="list-style-type: none"> (a) Residential and non-residential general service customers who receive service under Rate 311, Rate 315, Rate 321 and Rate 325, and (b) Customers who are current on their natural gas bill and have no past due balance <p>The rider is not available to CHOICE, Gas Universal Service, Dependabill or Price Protection Service (“PPS”) customers.</p>
Steps to enroll	Customer selects either the 100% (“Net Zero”) option, 50% option or the 25% emissions reduction option.
How will I be billed?	The additional charge for participating in the Green Path Rider will appear as a line item on your regular monthly NIPSCO billing statement.
How much will enrolling in the program cost?	<p>An additional cost of \$0.225 per therm, based on your selected participation level.</p> <p>Green PathSM Calculation Example:</p> <p><i>100% Participation Level</i> If you are enrolled in the 100% Participation Level and use 100 Therms per month, you can expect to pay \$22.50 more per month for Green Path.</p> <p><i>How it’s calculated:</i> 100 Therms used x 100% participation level = 100 Therms 100 Green Path Therms x \$0.225 = \$22.50 per month for Green Path</p> <hr/> <p><i>50% Participation Level</i> If you are enrolled in the 50% Participation Level and use 100 Therms per month, you can expect to pay \$11.25 more per month for Green Path.</p> <p><i>How it’s calculated:</i> 100 Therms used x 50% participation level = 50 Therms 50 Green Path Therms x \$0.225 = \$11.25 per month for Green Path</p> <p><i>25% Participation Level</i> If you are enrolled in the 25% Participation Level and use 100 Therms per month, you can expect to pay \$5.63 more per month for Green Path.</p> <p><i>How it’s calculated:</i> 100 Therms used x 25% participation level = 25 Therms 25 Green Path Therms x \$0.225 = \$5.63 per month for Green Path</p>

How will my bill be calculated?	The additional charge for Green Path Rider will be calculated by multiplying the percentage of your monthly gas usage you choose to participate in the Green Path Rider Program x \$0.225. This will appear as a separate line item and will be added to your regular NIPSCO rates and charges and applicable taxes will apply.
Will my rates change over time?	The Green Path Rider rate will be updated annually effective January 1 each calendar year. Enrolled customers will be notified of new rates before the new rate takes effect.
How are my emissions offset?	A combination of renewable natural gas (RNG) attributes and carbon offsets will be used to offset your natural gas usage to reach the level of the program emission offset option you have selected. NIPSCO will purchase a bundled offering of 5% RNG environmental attributes and 95% carbon offsets to reduce your emissions based upon the emission offset option you select.
How do I terminate this agreement?	You can end your participation in the Green Path Program anytime by logging into your account portal or by contacting NIPSCO Customer Service at 1-800-4NIPSCO (1-800-464-7726). The termination will take effect as of the start of the next billing cycle.
What length of agreement/ contract is required?	There is no special contract. Customers may terminate their participation at any time. The termination will take effect as of the next billing cycle.
